1.2. The Chairman is not responsible for executive matters regarding the Company's business. Other than the Chief Executive and the Company Secretary, no executive reports to the Chairman other than through the Board.	1.2 The Chief Executive is responsible for all executive management matters affecting the Company. All members of executive management report, either directly or indirectly, to him.

2.1. The Chairman's principal responsibility is the effective running of the Board.	2.1. The Chief Executive's principal responsibility is running the Company's business.
2.2. The Chairman is responsible for ensuring that the Board as a whole plays a full and constructive part in the development and determination of the Company's strategy and overall commercial objectives.	2.2. The Chief Executive is responsible for proposing and developing the Company's strategy and overall commercial objectives, which he does in close consultation with the Chairman and the Board.
2.3. The Chairman is the guardian of the Board's decision-making processes.	2.3. The Chief Executive is responsible, with the executive team, for implementing the decisions of the Board and its Committees.

3.1. Running the Board and setting its agenda	3.1. Providing input to the Board's agenda from himself and other members of the executive team.

Ensuring that he maintains a dialogue with the Chairman on the important and strategic issues facing the group, and proposing Board agendas to the Chairman which reflect these.
