



Anglian Waters internal training requirements for self-lay providers



This guide will explain everything you need to do in order to undertake specific activities during your main and service laying activities in our region.

What activities require internal training?

Everything listed below must be in place before working within our network.

There's external training and certification you need, as well as specific training delivered through Anglian Water.

External accreditation

There are three things any potential SLP must have in place:

They must be accredited under the Water Industry Registration Scheme (WIRS) for the type of work they want to carry out.

This involves undergoing technical assessments that look at design, construction, connections, commissioning and project management.

The WIRS is also a national accreditation and means that companies don't need to be approved by each individual water company in England and Wales.

They need to hold a EUSR National Water
Hygiene card and an in-date EU Skill card.

They must have someone who is a nominated train the trainer who can deliver the required WQ training for mandatory construction activities please see page 4.

Training

There are many different training offerings depending on the work the SLP wants to undertake.

Some are delivered by us via classroom-based sessions and others are delivered directly to the operatives by someone within the SLP who's accredited to be a train the trainer.

We reserve the right to audit any construction work to confirm that all training's in date.

Training is role specific depending on what work you need to do.

The **training matrix** to the right outlines a list of the different training modules and topics offered and who needs to undertake what in order to be accredited.

Remember, before starting any work you should:

- Review the work that you intend to do.
- Check that you have the correct external accreditations to do it.
- Check that all operatives have completed all mandatory Modules related to the activities being undertaken.
- Use the training matrix to check that each operative has the correct training and accreditation for their specific role or work they need to do.

Train the trainer

We offer all our Self-Lay customers free of charge training – making you aware of our water quality standards to undertake role specific and work on our network. This includes mains sampling, commissioning and valve operations.

- By the end of the training, an accredited Train the trainer will be able to deliver Modules 1 through to 6 of our training to their operatives through a series of easyto-deliver toolbox-style talks.
- The Modules build on the EU Skills Course to make sure our specific requirements are covered.

They are:

· Module 1:

Water (Supply Hygiene) POSWSH – mandatory for all operatives.

- Module 2: Working on services – mandatory for operations working on services.
- Module 3:
 Metering induction mandatory for operatives installing meters.
- Module 4:

 Mains opening mandatory
 for operatives working on
 potable water mains.
- Module 5:
 Mains laying mandatory for operatives undertaking mains laying.
- Module 6:
 Materials in contact (Reg 31)
 – mandatory for anyone in contact with, or responsible for ordering materials and design.

To continue to be an Anglian Water train the trainer, the trainer must:

- Maintain training records which must be available to us for inspection and audit purposes.
- Have a current email address on record with us.
- Must brief operatives of any updates to the modules that will be emailed to you.
- The SLP will be asked to provide the details of their accredited trainer at the point of application and precommencement stages of the scheme.
