PR24 Financial Data Tables Observations Summary Report (Draft Determination)

As part of your PR24 Business Plan submission following Ofwat's Draft Determination in July 2024, you requested us to carry out an independent review of your PR24 submission considering the methodologies and output data of the financial data tables within scope, in line with our engagement letter dated 30 November 2022 and the associated Statements of Work. The primary purpose of this letter is to communicate the scope and approach to our review and the significant findings and recommendations that we believe are relevant to your updated Business Plan submission.

For the PR24 Data Tables in scope, our work involved walking through the processes for deriving and populating the relevant data with management; checking for obvious errors and inconsistent formula within the tables; and conducting sample testing to confirm the population of the PR24 Data Tables within scope had been performed in line with the processes defined. Due to the limited timescales allowed, the scope of work was limited compared to our previous reviews, focussing on a smaller number of Financial Data Tables and considering those aspects that were new or had changed since the previous Business Plan submission.

Our scope encompassed those PR24 Data Tables listed as an Appendix at the end of this letter.

Overall we observed that Anglian Water had a defined process and approach to populating and reviewing the data tables. Data table owners demonstrated a good understanding of Ofwat requirements and were able to explain the rationale for the changes being implemented. The data within the PR24 Data Tables in scope was largely traceable to a preceding level of source documentation.

Where we raised exceptions, it was generally due to us being unable to trace information from the PR24 Data Tables back to the associated working papers and data sources. In the majority of instances, the



exception was resolved or explained satisfactorily by management. Where actions remained at the completion of our fieldwork, the Anglian Water PR24 Programme team confirmed these would be tracked through to closure, prior to submission of the business plan to Ofwat by 28 August 2024.

Where exceptions were noted as closed by Anglian Water, we confirmed changes to those data values where possible following updates made by Anglian Water, although this not always possible in all instances at the time of fieldwork completion. Where updates have been re-verified, we did not perform a full re-assessment on the entirety of each table.

We also highlighted areas where the controls in place for deriving and populating the data could be improved, and recommended steps that could be taken to improve the robustness of procedures. For the avoidance of doubt, any recommendations suggested are based on the factual review carried out in accordance with our scope of work. These are recommendations for Anglian Water to consider and decide whether to take forward. Anglian Water is responsible for implementing any recommendations that it does decide to take forward.

On the basis of our work these exceptions would appear to be individual and isolated points and did not indicate any wider systematic or pervasive issues.

We would like to take this opportunity to thank all those who have supported us in our work.
